# Lansing postal worker rally

CT Melinda Kochenderfer, a former U.S. Post Office employee, is very aware of how proposals to "reform" the U.S. Postal Service will affect workers and communities.

Kochenderfer's husband works for the USPS. Together, they attended the September 27 "Save the Postal Service" rally in Lansing.

"The Post Office provides a good, honest job, one people used to be able to live on," Kochenderfer said. "If offices close, there'll be more people out of work.... I hear politicians talking about 'creating jobs,' while on the other hand, some are proposing legislation to 'consolidate services.""

Postal workers are trying to counter what they call "misleading claims that the Postal Service is broke, that it loses billions of dollars a year delivering the mail, or that a taxpayer bailout is imminent."

According to the four employee unions of the USPS, the Postal Service has not used a dime of tax-payer money in 30 years, customer satisfaction is at an all time high, and it has earned \$611 million net profit over the past four years, despite the worst recession in 80 years.

Proposals to limit service and consolidate facilities are unnecessary, the unions say, and will jeopardize a crucial service. While demands on those services have changed, the USPS has always been able to adapt. For example, people are paying more bills online, but they are also ordering more online, and the USPS is a huge part of the delivery network.

The unions say that the biggest problem is a bill passed by Congress in 2006 that requires the Postal Service to pre-fund 75 years of health care benefits within 10 years. It is a burden that no other government agency or private company bears. [Jodie Schonfelder]

The unions are supporting H.R. 1351, which would allow the USPS to apply billions of dollars in pension overpayments to meet its financial obligations.

The four USPS unions are American Postal Workers Union, National Association of Letter Carriers, National Postal Mail Handlers Union, and National Rural Letter Carriers' Association. For more information, visit www.saveamericaspostalservice.org.

We have gone through budget cuts and layoffs and have maintained our Contractual layoff language. Our contract still provides us with strong layoff and placement language. The bargaining team vehemently opposed any changes to this language during negotiations. Remember, we have bump and by-pass rights campus wide.

Considering the volatile political and economic climate, we understood that we needed to have a Contract in place as soon as possible, but were prepared to negotiate as long as necessary. When we were satisfied that we had the very best agreement we could reach, in this climate, we were ready to present it to you for ratification. Members turned out, in high support, the count was 500 yes and 19 no. This was an overwhelming statement of confidence in your bargaining team and in support of the CTU Contract. I was excited and pleased to see such membership support. Thank you!

Don't lose site of the fact that work and life balance are essential to our body, mind and spirit. We are still hearing far too much anti-union and budget shortfall talk from the government! We are empowered by our Contract and don't forget that!
