# Labor fighting back

The current anti-labor climate is giving union workers plenty of opportunity to stand up, show solidarity for each other and make our voices heard on crucial issues that affect the middle class.

Wisconsin is in the middle of recalling a governor who continues to sign anti-worker bills into law. Ohio voters threw out legislation that limited collective bargaining for public employees in November. Workers in Indiana, which became the twenty-third right-to-work state in February, are fighting to restore their right to democratically choose union representation.

In the midst of an onslaught of legislative attacks on labor, Michigan workers are also fighting back. We have launched a petition drive to head off the possibility of a right-to-work law in our state.

As a group that supports the rights of workers to decide for ourselves—through the democratic process—whether or not to form a union, the CTU has long been on record as vehemently opposing right-to-work laws.

The petition needs over 300,000 signatures by July 1 to be included on the ballot. We need to encourage our coworkers, our family members, our friends and our acquaintances to sign the petition and vote for the "Protect Our Jobs" amendment in November.

## Red Cross strike affects community

April 11, Lansing—Approximately 200 workers are on strike against the Red Cross in Lansing. Red Cross has refused to bargain with the workers represented by Teamsters Local 580 and OPEIU Local 459 over cuts to health care benefits and wages. The

workers also contend that the Red Cross is implementing changes that compromise the safety of donors and the blood supply.

#### Postal workers speak out

Lansing area postal workers rallied outside Senator Carl Levin's office on April 12 to protest the planned closing of the Collins Road mail processing facility and bring attention to federal legislation that deliberately undermines the fiscal solvency of the U.S. Postal Service.

The closing of the Collins Road site is part of a nationwide plan by USPS to save \$3 billion by consolidating **postal** continued on p. 6

## Stewards of our community

"Community."

We hear and see this word a lot lately but what does it really mean?

When I "googled" the word community, I came up with this definition from Wikipedia, the free Internet encyclopedia:

The term community has two distinct meanings: 1) A group of interacting people, living in some proximity (i.e., in space, time, or relationship). Community usually refers to a social unit larger than a household that shares common values and has social cohesion. The term can also refer to the national community or international community, and, 2) in biology, a community is a group of interacting living organisms sharing a populated environment.

In human communities, intent, belief, resources, preferences, needs, risks, and a number of other conditions may be present and common, affecting the identity of the participants and their degree of cohesiveness. . . .

The word "community" is derived from the Old French communité which is derived from the Latin communitas (cum, "with/together" + munus, "gift"), a broad term for fellowship or organized society.

This definition reveals that the word has more depth and resonance than I realized, especially the Latin origin, which recognizes "community" as a coming together and a social gift. I thought of community in more general terms—a collec-

tion of groups and individuals operating in a given space—but it certainly *can* be a gift when it serves the society or populated environment for the good of all.

This is how I choose to see "community." We are called to serve each other and the greater good of the collective. That is unionism as its best. When we work together, we can accomplish so much more. We become a powerful voice for the individual and the group. We become a force to be reckoned with!

Now we need to come together as a community more than ever, as you can see from stories on the front page of this newsletter. We are attacked by the legislature. We are attacked by the press and in editorials. We are seen as greedy and obsolete. Even our families, friends and neighbors sometimes lob nasty comments our way and perpetuate stereotypical myths that put unions in a bad light. It can be hard to take and even harder to fight.

However, the newsletter also gives us a more accurate portrayal of unions.

We see long time, loyal employees receiving service awards.

We see an announcement for the Gliozzo Award, which was started in recognition of CTs who perform at the highest level to serve students and coworkers, CTs who embody the spirit of community. [Becky Sullivan]


We also see CTU stepping up to help with another fundraiser, this time by co-sponsoring MSU's Summer Circle Theatre, which will help students and the greater community.

We see on the front page, groups joining together to protect decent jobs, a voice for workers and the safety, health and interests of the community at large.

CTs are the community and we benefit from it—from the collective outpouring of goodwill during our strike in the 1980s to the individual assistance many of us have received from voluntary agencies when necessary. Even with a job, members sometimes need help getting out of an abusive relationship, dealing with a sudden loss or emotional crisis, managing care for an elderly loved one, etc. Any one of us might find him or herself in such a situation.

CTs are the community and we need to take our responsibility for supporting it seriously, both by assisting local charities and other endeavors and by making our voices heard on issues that affect us. Workers and their unions created the middle class. Now that we are under attack it is imperative that we fight to protect it.

CTs *are* the community, and it is up to us to help define it.

April 11 while the strike continued. At the time we went to press, negotiations were reported to be rocky.

Because several blood drives were scheduled on campus during the strike, the CTU sent an email out through its listserv and posted information on its website informing members as to how to respond to picket lines at their buildings. The message also responded to inquiries about how CTs can assist the strikers.

Members may remember how important community support was to the success of our own strike in 1988. Legally, we are unable to leave our jobs to strike with the Red Cross picketers. However, there are several ways we can show our support, such as joining the picketers on breaks and lunch hours, honking our horns as we drive by, making donations to help pay for medical and other bills, etc.

mail sites and ending Saturday delivery. [Deena Kakirjan-Kalbach]

The workers do not believe that many of the changes are necessary. They say the crisis was created by recent legislation that requires the Postal Service, which is completely self-funded, to pre-fund future retiree health benefits for the next 75 years and do so within a decade. This law, they believe, needs to be overturned.

If a distribution center does need to be closed, they add, it should not be the one in this area.

The consolidation plan calls for

Lansing services to be moved to Grand Rapids. Not only would such a move result in slower mail for the capital city area, it would be more costly and demand more resources. Lansing is more centrally located in the region than Grand Rapids, so remaining here would result in less mileage and lower fuel costs. Also USPS owns the Collins Road site, meaning it would not have to pay rent here as it would in Grand Rapids.
