Health care update

Open Enrollment

The Open Enrollment period, when we choose our health care plan and options for 2010, is April 19 through May 10. Our options will include the changes we approved when we ratified our Health Care Memorandum of Understanding (MOU) earlier this year. Because of the number of changes, it is important that we get all of the information before making personal decisions about our health care coverage.

Community Blue will continue to be one of the plans offered. The other option is Blue Care Network (BCN), this year's fully funded plan. Full-time employees will not have a premium deducted from their paychecks for the BCN option. Those choosing Community Blue will pay the difference between the two plans. See the table on page 5 for a breakdown of contributions.

Detailed information about the health care plans is available in the 2010-2011 Employee Open Enrollment Packet available on the MSU Human Resources website at www.hr.msu.edu. The packet gives the schedule for Benefits Fairs where vendor representatives and MSU Human Resources Benefits staff members will be available to answer questions as well as the two dozen one-hour informational sessions that are being offered to discuss the new BCN plan.

One difference this year is our ability to

Have you heard? The economy is turning around. Yeah, right! Look around our state, and the problems seem to be getting worse, not better. Must be that "jobless recovery" I've heard about.

I heard a tax preparer say recently that a lot of people in our community are getting higher state and federal tax refunds. Great news! Then she clarified that the higher refunds were the result of lower incomes and unemployment. That kind of puts a damper on it.

These are hard times. Those of us who have a job are anxious about losing it and we struggle for something to say to neighbors, friends or family members who might not. It is easy to complain and be angry. It is really easy to complain about taxes, school millages, rising costs, and the bills that seem to nag at us from every corner of our lives. We are bombarded.



The flowers are popping and the streets are snow free, so that means it's time for biking! There's no better way to enjoy the spring weather, save some \$\$ and burn off some winter calories.

If your bike was in good riding shape in the fall or end of last summer chances are it just needs some air in the tires and oil (use proper chain oil sold in a bike shop) on the chain and you'll be off and riding.

If your trusty steed has been languishing in the garage or basement for longer, it'd be a good idea to have it checked over by a bike shop, like your friendly shop on campus, the MSU Bikes Service Center. A tune-up once a year is good preventative maintenance to avoid more costly repairs and aggravation down the road, not to mention giving you a more enjoyable ride. We also have a free air-station outside our Center available 24-7.

If you don't have a bike, consider buying or renting one from MSU Bikes where they restore/recycle old abandoned or privately donated bikes and get them back on the road either through sales or rentals. Or, if you've got an old bike that you're not using any longer and would like to see it go to someone who's needing a bike, please consider donating it to MSU Bikes (you'll get a tax credit and MSU Foundation donor points).

Established by Vice President of Finance and Operations Dr. Fred Poston in the fall of 2006, MSU Bikes is one of just a small number of university-owned bike shops in the country. It was built to encourage more bicycle use on our campus to help keep us more "green," improve the health of our community and reduce motor vehicle traffic and parking congestion.

enroll an "Other Eligible Individual," or OEI. The criteria for qualifying as an OEI are detailed in the packet. Support staff who have covered same-sex domestic partners in the past need to be aware that there is no automatic transfer of Same-Sex Domestic Partnership Agreements into the OEI program. Members must meet the OEI program criteria in order to enroll someone for benefits under the OEI program. The form is available at www.hr.msu.edu/forms.htm. OEI benefits are taxed, so anyone interested in this program should be aware of the tax impact.

As in past years, anyone making changes in coverage—such as adding or removing a dependent, switching health or dental care plans, or changing life insurance options—must participate in Open Enrollment. Staff members who wish **to continue coverage** for a spouse or OEI must participate by filling out the affidavit.

You do *not* need to go through Open Enrollment if 1) you are not making changes, and 2) you are not covering a spouse or OEI. [Teryl Hall]

Anyone currently enrolled in PHP who does not want to be automatically switched to BCN must participate.

To access Open Enrollment, go to the Human Resources Website and then sign on under "eHR Login." Click on "Benefits Enrollments & Information." Select the appropriate link and proceed. All unions on board

We are happy to report that the MSU members of the International Union of Operating Engineers Local 324 (IUOE) will be joining the rest of the unions in our ongoing health care talks with the University. The Operating Engineers held another ratification vote which resulted in their accepting the Health Care MOU.

In addition to working to keep health care costs down and quality up at MSU, the unions will be investigating the impact of the newly passed "Patient Protection and Affordable Care Act" on our health care plans, and they will share this information as it becomes available.

Retiree health care

On April 13, we received President Lou Anna Simon's statement that MSU intends to eliminate employer-paid post-retirement health benefits for employees hired on or after July 1, 2010.

This change applies only to individuals hired *after* July 1 of this year.

The unions did not agree to the elimination of these benefits during health

care negotiations. However, expecting the University to pursue this path, the unions did sign a letter of agreement requiring both sides to meet "to bargain over the terms of an exit strategy" in the event that MSU found it necessary to eliminate the benefits. The unions will now meet with the University to discuss options for new hires that would provide health care assistance upon retirement.

Board actions

Mid-December 2009—March 2010

The following CTU Executive Board discussions took place mid-December 2009 through March 2010. All expenditure decisions are included, but the list does not represent meetings in their entirety. December 15, 2009

Agreed to send both Contract Administrators to Labor Law and Arbitration Conference in Chicago, at a cost of \$395 each plus lodging of \$165 each and transportation at the lowest rate available.

Purchased eight tickets for a total of \$200 to attend the Greater Lansing Dr. Martin Luther King, Jr. celebration luncheon.

Agreed to send up to two CTs to the Michigan State AFL-CIO/UAW-CAP/ Labor Council Community Services class for \$30 each. [Editor's note: No one attended and funds were not spent.]

Authorized up to \$300 toward purchasing a portable printer with blue tooth adapter.

January 5, 2010

Agreed to recommend approval of Health Care Tentative Agreement. Set ratification for February 3 with vote counting on February 4.

Turned meeting over to a union leadership presentation on the Health Care Tentative Agreement by members of the Coalition of Labor Organizations (CLO) bargaining team.

January 19

Transferred \$50,000 from Operating Savings to Operating Checking.

Voted to send up to four individuals to the Labor Education Program's

Employment Law Update Conference at a cost of \$125 per person.

Received reports on Martin Luther King, Jr. luncheon and Labor and Employment Relations Association (LERA) presentation.

February 2

At the request of a member, donated \$50 to TJ's Thunder fundraising dinner for Juvenile Arthritis Donation to go to the Arthritis Foundation, Michigan Chapter.

Discussed CTU fund transfers, preparations for the vote on the Health Care Tentative Agreement, progress of suing individuals delinquent in paying back Gerri Olson Lottery Loans, the upcoming Executive Board retreat, and the successful fundraiser for Ingham County Animal Shelter.

February 16

Agreed to purchase OPAC Office Skills, Clerical Skills Software Assessment Testing program so CTU members can practice the specific placement tests utilized by MSU.

Agreed to send up to two people to the Labor Notes Conference at a cost of \$85 per person, \$115 lodging, plus reimbursement for meals and mileage.

Approved \$100 sponsorship of The Michigan Summit 2010: "A Blueprint for Change." Sponsorship allows a vendor table and five attendees.

March 2

Received report from CTU Investment Advisor Fred Schaard on our investments for the past year. Our investments showed a gain of over \$300,000 in value last year. We are receiving an 8% return on our investment portfolio at this point and have outperformed the index.

Transferred \$20,000 from operation savings to operations checking.

Purchased a \$35 ticket for a Board member to attend the Annual Ingham County Animal Shelter Humanitarian Awards Banquet.

Received Treasurer's report that \$6,000 in delinquent Gerri Olson Lottery Loans has been collected.

March 16

Accepted the 2010 CTU Operating Budget as presented by the Finance Committee with some modification.

Received announcement that CTU President Deb Bittner will serve as interim president for the CLO until an election can be held in June.

Received reports on new Union Representatives (URs) stepping forward, employee training at University Services, union training, and building repairs. [Edyth Holland]

Decided to limit regular, ongoing attendance by CTU board and staff to monthly LERA lunch meetings to two individuals (down from five).

Like all small businesses, we have bills to pay that are not getting smaller. We pay taxes. We maintain a facility. We try to be a good employer. However, with fewer members we have less money coming in. The CTU membership has fallen to approximately 1,700 from a high of 2,500 in 1988. And that means less dues revenue. However, we still demand the highest quality services. We still need to negotiate contracts (like the recently ratified Health Care Memorandum of Understanding). We still need to demonstrate that CTs are an integral part of the campus and the community.

And we still need to save money wherever we can and in any way that will not compromise our high level of service. It is a tough balance. Just as almost every other business and government agency in the state, CTU has been looking closely at expenditures and cutting where possible. We discuss thoroughly why or why not to contribute to a cause or buy new equipment. We look at purchasing building supplies from low cost, but still union and "made-in-America," companies. We especially like to purchase items from MSU Stores or the new Surplus Store. We rent vehicles from MSU's Motor Pool to cut costs. We do our best to make the dues dollars go a long way.

However, the formula that allocates money to operations never seems adequate for the work that we need to do. Layoffs, workplace issues, contract enforcement—these duties haven't decreased with the bad economy or declining membership. We still need to be the strong union our founders created us to be.

Therefore, the CTU Executive Board will propose a transfer of funds from our contingency fund to operations at

the Membership Meeting on Wednesday, April 28. Additional information about the proposal will be distributed before the meeting.

A few years ago, we decided that this is the best way to manage our budget—come before the membership, lay out the budget and our expenses, discuss all of it and then ask the members to vote to transfer money. This process has served us well, as long as we have enough people present to do the business of the union. Fifty members are required for a quorum.

Please try to make this meeting and help us with these discussions. We will also have our annual audit review by our long-time chief accountant, Jim Nyquist of Maner Costerisan, P.C.

The Membership Meeting will also provide an opportunity to discuss issues of concern to CTU members and to provide feedback on ideas that the Executive Board has for increasing member involvement. Because April 28 is Workers Memorial Day, we will spend a little time discussing the increase in workplace injuries that seems to be running parallel to a decrease in the enforcement of safety regulations, a situation made grimly apparent by the recent deaths of miners in West Virginia. [Josette Pashkowsky]

The Membership Meeting does have its bright spots. Light refreshments, courtesy of our Solidarity Committee, will be available. And the door prizes and other giveaways are always a hit. More important, however, is the fellowship of meeting other CTs and hearing how they have handled problems in the workplace. It is a real stress reliever to be with others in the same boat who understand what we're going through. There is, after all, strength in numbers! Hope to see you on April 28!
