# One nation: bringing back the American dream

As I wrote in last month's edition of the CT News, we are in the political season for CTU and beyond our campus borders. The state and national elections seem to be taking on a particularly intense and nasty tone. So what's at stake to cause this level of intensity? Why is political power so important? Why should we care? Does it really affect us at MSU and CTU?

Also, in last month's issue, we ran my favorite writing by the late MSU Professor Dan Kruger who told us that "In a democratic society the extent or magnitude of political power gives unions their voice and their seat at the great social negotiating table provided by democracy. . . . The greater the political power, . . . the greater the bargaining power." [Quinn Marie-Wilson Kroll]

He also reminded us that "Political action is part and parcel of a free democratic society, and unions, as part of the democratic community not only do

engage in political action, but are obligated to do so on behalf of their members and their interests."

So, in that spirit, I joined several other CTs at the One Nation Working Together March on the Mall in Washington, D.C. on October 2. Four of us traveled down on a bus organized by the Peace Education Center in East Lansing that left on Friday, October 1, and returned Sunday, October 3.

While traveling on a bus for 12+ hours each way left me questioning my sanity, I truly appreciated the opportunity to participate in this historic event. The view of the Mall in Washington was breathtaking as we joined the tens of thousands of everyday citizens engaging in democracy and political action. It was especially moving to walk by the beautiful World War II Memorial and to look ahead to the Lincoln Memorial, both symbols of our struggle for peace and democracy.

It was quite an overwhelming scene, right out of the history books, to be in our capital and be part of this reminder to our politicians and the press that we matter. There were people from all walks of life and from around the country, union and nonunion, independent unions and international unions, young people and old people, with hundreds of thousands of members of the groups carrying flags and signs with calls of support for the working people of America. Reporters from around the world also were there covering this event. We saw news resources from C-SPAN, CNN, ABC, NBC, MSNBC, Austria, Mexico, Pakistan, Italy, China, England,



Russia and more walking among the crowd to ask questions on why attendees choose to come to the One Nation Working Together Rally.

The organizations that form One Nation support the union movement's agenda of an economy that works for all: good jobs, fair jobs, safe jobs, and more jobs; . . . quality public education for every child (something near and dear to our lives as public employees of an institution of higher education); and ensuring that everyone in America has the opportunity to contribute to and strengthen our country, according to the statement.

The idea behind the rally was based on the simple need that citizens felt that it was important to come together and fight back for what this country needs to survive: JOBS and to bring the other issues forward in order to save our economy. Basically, we need to work together and get America Back to Work.

The One Nation Council statement said it best when it issued this rallying cry to workers:

Working people can make a difference when we rely on ourselves and act collectively. We are America. And together we can make our voices heard.

Let's remember that we are working America when we get to the voting booths and vote for those who support labor.




