October 27 elections

embers of the CTU go to the polls Tuesday, October 27, to choose a president, vice president, treasurer, four directors and a member of our Audit Committee.

Pages 6-11 of this issue provide statements by the candidates and other information to help us make our decisions and cast our votes.

Any questions, concerns, complaints or comments about the elections process should be addressed to a member of the Elections Committee.

According to our constitution, Executive Board officers and directors are elected to two-year terms, and the term of vice president ends in even-numbered years.

However, we lost our vice president earlier this year when Kim Smith took a job outside the bargaining unit. The Executive Board then appointed Director Rosie Garcia to fill the position until an election could be held. Now we need to elect someone to fill the vice president position for one year—until October of next year—when the regular election will be held for the office.

Garcia's move into the vice presidency also opened up the remainder of her director term, which is why we have a one-year director position on the ballot.

Candidates

This election sees one candidate running for each of the officer positions (president, vice president and treasurer), four candidates for the three open two-





Open enrollment

long with the rest of MSU employees, CTs will make choices in October about their 2016 health care plans and other benefits.

The premium contribution for those choosing Community Blue (CB) health care insurance will increase in 2016 (see chart below). Employees opting for Blue Care Network (BCN) insurance will continue to pay nothing toward the premiums. Employees will have no premium contribution toward prescription coverage under Caremark.

[The employer's contribution is pro-rated for 1/2- and 3/4-time employees, so rates for part-time employees will be proportionately higher.]

Dental care

As a result of our recent negotiations, those choosing the Aetna Premium Plan will pay a monthly premium (see chart at right). However, copays are eliminated or reduced compared to last year's Aetna plan.

The Delta Dental option is unchanged.

Please consult the Open Enrollment guide and consider attending the Benefits Fair to help you understand all of your health care options.

Who needs to enroll?

You MUST participate in Open Enrollment if you are making any changes in coverage—which includes adding or removing a dependent, switching health or dental care plans, and changing life insurance or voluntary benefits options.

If you want the new Aetna Premium Dental Plan, you must go through Open Enrollment even if you were enrolled in the old Aetna plan.

You must also go through the Open Enrollment process if you plan to enroll or continue enrollment in an FSA.

Even if making no changes, staff members who wish to continue coverage for a spouse or OEI must participate by filling out the affidavit.

Enroll through the EBS Portal under ESS > Employee Self Service > Benefits > Add or Change MSU Benefit and Retirement Plans > Open Enrollment.

Every year, CTU members, our families, our friends and our neighbors benefit from these programs, especially when one of us falls on hard times or has an emergency need. And we all benefit when our communities are healthier, when the children in our neighborhoods have access to high quality after-school programs, or when families receive the support needed to stay strong and stable.

Going for greater participation

Donations have been down in the last couple of years.

This may be due, in part, to the discomfort some people feel about using the electronic pledge form, but Jeff Brodie, co-chair of the Campaign, points to additional reasons such as a lack of understanding on the part of some newer employees about the importance of the Campaign.

Brodie said the Campaign needs to bring more young people into leadership, "so we can better reach out to their peers, and . . . replace legacy volunteers who have either retired or changed jobs so they are no longer active."

"This year we are committed to bringing not only donations, but also participation, to levels that existed before the Great Depression!" Brodie said.

It is true that many individuals are finding that the economy has had a serious impact on their ability to contribute—right at a time when the need is growing. Our donations may be small, but if more of us give, our impact can be enormous. The important thing is just to participate and give what you can.

Electronic giving or paper

Electronic donations save thousands of dollars and reams of paper.

For various reasons, however, some employees do not want to give electronically via EBS.

There is also a procedure for individuals who don't like making financial transactions via the internet and wish to donate the old-fashioned way. See the box at left for information.

Labor's leading role

Labor has always made a big difference in the community through service and donations. [Kim Garrison]

Recognizing that CTs work in unity with other union members who share our commitment, camaraderie, and teamwork, MSU's Community Charitable Campaign reports what the MSU labor family does to help others. The donations of CTs are reported as a group along with the donations of other labor groups on campus.

Also, a statewide "Labor Leads" registry is published each year that recognizes United Way labor donors that have made leadership pledges to their respective United Ways in amounts of \$250, \$500, \$750 and \$1,000 per year.

Choices

MSU has an open campaign, meaning donors can choose the non-profit organizations to which they wish to contribute, and the Campaign makes sure the charities are legitimate. Gifts may be directed to a specific service area, to a specific listed agency or any IRS approved tax exempt organization.

The gift may be given in one lump sum or increments through payroll deduction (taken from paychecks twice a month).

Audit Committee positions are for three years, and one person is running for the Audit Committee.

We may need to fill a one-year position on the Audit Committee after the elections. Stephen Stofflet, currently serving on the Audit Committee (term to expire October 2016), is running for the one-year director spot. If elected to the Board, the remainder of his Audit Committee position will be available.

Director Willie Paulsen, having served one year of a two-year directorship (term to end October 2016), is running for a director position that ends in two years. If elected, we will need to fill the final year of her current director position.

Although only one person is running for most positions, we still have a choice because our constitution requires the option of a "no" vote under such circumstances. [Kendra Deyarmond]






Voting absentee
