I learned my position was being eliminated from a slide presentation at a departmental meeting."
 "I requested a reclassification. My supervisor said yes but nothing has been done." [Sally Schoch]

These are just two of many recent issues for which members have sought assistance from our union representatives.

Our URs—members who have stepped up to fill the role—are responsible for building a solid union foundation at every work site by promoting an informed, unified and active membership. UR duties include assisting members with problems on the job and making sure that we are all communicating with each other. They are our "front line" in the workplace.

Elections Committee Chairperson Liz Owen presented the results of the election at the next evening's Membership Meeting. Because we fell short of a quorum, the Executive Board convened a meeting to accept the results of the election and the winners were sworn in. President Bittner thanked the members of the Committee, plus the many volunteers and staff who worked to make the process a success.

Treasurer Jan Wallace discussed our budget and investments.

The elections process

Bittner then raised the need to examine our elections procedures with the aim to engage more members in voting and avoid the expense and disruption of yearly elections.

"With yearly elections, the Executive Board sometimes postpones decisions until the 'new' members are on board," she said, adding that "the process itself causes a great deal of disruption in the office and with the staff."

She said that she believes we should

choice over our own lives. This can only be accomplished if members' individual talents and skills, as well as our concerns and suggestions, are transformed into purposeful collective action for change.

explore alternatives that strengthen our union's democracy while enhancing our speed and agility in defending our rights under the contract.

"It's a conversation we should have over the next couple of months," Bittner said in response to a member's suggestion that we go to online voting. "I'm not sure online voting answers our needs. And looking at other unions who have tried it, it doesn't seem to increase member involvement or the number of people voting over time. But it's one more thing to look at."

April 2016 raise

he numbers are in: our health care expenses have resulted in a 1% general wage increase that will take effect for CTs on April 1, 2016.

The increase is the second under the 2014-17 Health Care Agreement nego-

tiated between the Coalition of Labor Organizations and the administration at MSU, and ratified by us in the summer of 2013. Under the agreement, raises are tied to increases in the cost of health



care. As health care costs increase, raises are negatively impacted.

We received our first increase under this contract—2.5%—on April 1, 2015.

Each of the eight unions affected by our agreement has a different contract cycle and the employees they represent get their raises accordingly.

CTs who have not reached the maximum of their pay grades will continue to receive an additional wage progression of 3% per year under our current contract.
