## The power of participation

#### Quorum!

Another goal was to get a quorum at our first Membership Meeting of the year. As you know, we need a quorum of 50 members to do "official" business. Without that, we still have spirited discussions that are very instructive to the executive board, which acts on behalf of the membership between member meetings with a quorum.

Per our constitution, however, we do need a quorum to make certain decisions as an organization, such as transferring money from our contingency fund to reimburse operations for negotiating expenses.

We also prefer to leave decisions about major donations to the membership. Lacking a quorum, the executive board asks the members present at a meeting for input on large donations.

Whether or not we have a quorum, we always talk about current issues and formulate plans of action.

But to me, the most important part of our Membership Meetings is the solidarity. We are reminded that we are not alone in our workplaces, and we are not alone in our efforts to do our best to support students and the university. As CTs, we are part of a collective organization that backs us up with a strong contract, a strong organizational foundation, and a strong community presence. CTU President Deb Bittner read from the statement: "We believe unions are the vehicles by which ordinary people can achieve extraordinary things."

Our mission statement is an important part of our union, Bittner said, and guides us in making decisions about policy and actions.

#### **Transfer**

We also voted to move \$71,802.13 from the contingency fund to operations in order to cover 2014-2015 negotiations expenses and litigation regarding the health care stipend law suit.

#### **Community participation**

The membership also voted to donate money to several community services and activities: \$1,000 to the Greater Lansing Food Bank, \$500 to the MSU Student Food Bank, \$500 to MSU Safe Place, and a \$500 labor donation to the Genesee County United Way to assist in the Flint water crisis.

CT Shawn Rayon said he was willing to put together a team for the "Race for the Place" April fundraiser for MSU Safe Place. Anyone interested in joining the team should contact the CTU office at 517-355-1903 or ctu@ctumsu.org.

Director Willie Paulsen collected donations for the third annual "Sock It" drive, including several scarves made by a CTU member. Paulsen is accepting donations of socks, gloves, hats, and coats through the end of February and can be contacted at *paulsenw@msu.edu*.

Bittner said that the 60/50 conversation on civil rights and inclusion initiated in 2014 continues. She highlighted the 60/50 Quilted Conversations project (see p. 1) and encouraged members to participate. She added that a quilting group that meets at our office regularly is going to make a panel for the project.

tract Administrator Dan McNeil. He added that he has agreed to consult and assist as needed.

Several members thanked him for his contributions and said they were sorry to see him leave.

Bittner said that the Personnel Committee has started to look for candidates for the position.

## Health care savings disbursement

In further discussion, Bittner congratulated the APA on winning its recent arbitration. Two other MSU unions have filed a similar arbitration.

Bittner explained: Support staff on the payroll on January 1, 2014, and/or January 1, 2015, received disbursements of savings accumulated under our previous health care contract. The university withheld a portion of the disbursements because of a lawsuit filed by a retiree. The arbitrations seek the release of a portion of the monies withheld.

CTU did not file for arbitration, she said. While we agree that the University did not have the "right" to withhold the money, the CTU chose to forgo the cost of an arbitration and allow employees' money to accumulate interest while waiting for the lawsuit to work its way through the legal system. We figured that having the university force CTs to

repay the money (on the off chance of an unfavorable legal outcome) would be the bigger hardship, she said.

"We join the other MSU unions and the University in our belief that the lawsuit is without merit," Bittner said. She added that we fully expect our savings to be distributed in the near future.

She pointed out that only employees who were on the payroll on January 1, 2014, and/or on January 1, 2015, are affected. [Rosemary Shubeck]

#### **Audit Committee**

UR Stacey Patton stepped forward to run for the Audit Committee and was elected unanimously. She joins Heather Dover and Shawn Rayon on the committee.

#### Other business

Bittner reminded us of the 1% general increase we will receive as of April 1 and said that individuals' participation in Best Doctors helped secure it by saving on health care costs.

Bittner addressed the new Performance Excellence evaluations and advised CTs to take the online training. She added that CTs should contact the union office if they have problems setting time at work to do the training. McNeil said that the self-evaluation piece of the new process is meant to be a tool for the employee and is not supposed to be part of the personnel file.

Bittner said that the right to work law leaves us with some concerns about the CTU constitution and asked for volunteers to participate in a committee to review it.

And it's still not over.

One way to join the conversation is to participate in some of the many events connected with the project. CTU is adding a 60/50 tab to the drop-down menu on our website (www.ctumsu.org) that will connect visitors to the 60/50 calendar and other useful information. There are many interesting, fun, and informative events and projects from which to choose. More are being scheduled all the time, so check back often.

For example, one project invites us to be part of creating a community quilt.

Simply submit a 12x12 inch square on a civil or human rights issue important to you and it will be stitched with others to create three large quilts. The deadline is March 25 and the deadline for a children's quilt project is April 22.

"Why quilts?" asks a flier for this project. "Quilts carry culture. Traditionally made by many hands, from scraps that each hold a story, the quilt is an art form that reflects history—both personal and communal."

With conferences, presentations, movies, a video website, museum exhibits, public "common table" meetings, a newsletter, and service opportunities, Project 60/50 provides scores of ways to participate in the conversation.

Project 60/50 was launched at MSU in 2014 to acknowledge the 1954 *Brown vs. Board of Education* decision and the passage of the 1964 Civil Rights Act.

#### October through December 2015

Poard meetings are regularly scheduled twice a month, on the first and third Tuesday, and members are welcome to attend starting at 5:15. The CTU constitution requires the Executive Board to meet at least once a month.

The following Board actions took place October through December 2015. All expenditure decisions are included, but the list does not represent meetings in their entirety. Members can receive copies of complete minutes through the mail or email by contacting the CTU office at 355-1903.

#### October 6

Discussed management's inconsistent approach to reclassifying CTs.

Agreed to publicize the opportunity for CTs to assist a member with a difficult family medical situation.

Received report from CTU's representative to the All University Traffic and Transportation Committee (AUTTC): Retirement parking issue has been dropped.

Received report from CTU's representative to the President's Advisory Committee on Diversity and Inclusivity (PACDI): 1) year's focus will be web accessibility, and 2) PACDI will help coordinate celebrations commemorating the 25th anniversary of the Americans with Disabilities Act.

Received treasurer's financial report. Decided to purchase three computers at a total cost of approximately \$3,362.48. Current computers are well over 10 years old and unable to accommodate updates and current software.

Agreed to send up to two directors, at \$135 per person, and the president, at the \$75 judge rate, to the Michigan

Women's Hall of Fame Induction Dinner for a total of \$345.

Agreed to donate a \$125 item for the Tri-County Office on Aging Annual Dinner and Silent Auction.

Received President's report on benefits Open Enrollment and the "shared services" pilot program.

#### October 20

Received vice president's report on the URs' "walk through" of their districts.

Discussed new member procedures. Received report that the October Detroit area LERA meeting was canceled.

Received information that tickets are available for the Fraternal Order of Police "Country Music at its Best" festival.

Discussed the agenda for the upcoming Membership Meeting.

Discussed executive board meeting schedules for November and December.

Robertson donated a quilt painting to CTU. It will be placed in the small conference room or in the lobby.

Received a report on finances from the president in the absence of the treasurer.

Renewed subscription to the Lansing State Journal for \$407, including a \$61 gratuity for the delivery person.

Tabled decision to purchase additional cyber security insurance for \$1,000 per year until more information is available.

Received president's report, which included an update on the impact of right to work on new memberships. We are tracking inconsistencies in new member information sent by the university.

#### **November 3**

Received treasurer's financial report. Discussed the need to print new membership cards.

Donated \$100 to the Old Newsboys and an additional \$10 for mailing a copy.

Donated \$100 to Salvation Army of Lansing for warm clothing purchases.

Agreed to send up to two people, at \$50 person, to MSU Labor Education's program: The Affordable Care Act and Its Impacts on Health Care Plans and Bargaining.

Received president's report that our April 2015 raise is projected to be 1%.

Discussed agenda for the upcoming CTU leadership retreat: Review board policies and educational loan charter, plan organizational direction; develop a process to update the constitution.

Established dates for 2016 membership meetings: January 27, April 21, July 14, October 26.

Established executive board constitutional committees for 2016. Finance: Treasurer Jan Wallace (chair), Pamela Brock, Sierra Matthews, Walt Peebles, Jeanette Roberts. Grievance, Arbitration, and Trial: Vice President Rosie Garcia (chair), Willie Paulsen, Tracy Rich, Pam Sloan, Steve Stofflet.

Established the Personnel Committee: President Deb Bittner (chair), Rosie Garcia, Pam Sloan, Jan Wallace.

Discussed the scheduling and logistics of CTU's new member orientations.

#### **November 17**

Received treasurer's financial report and discussed the need to postpone purchase of computers until funding is secure—probably December.

Agreed to purchase a \$40 business card-sized ad in the Greater Lansing Area MLK Holiday Commission program.

Donated \$250 to the Capital Area United Way Labor Challenge. With our donation, we help support essential programs and services in the area (some of which are used by our members and their families) and get our name listed in the program.


#### Article 24. Communications




