## President's corner Why union members should be involved

magine: Sending your 13-year-old child off to work instead of school. Working six 10-hour days a week with no minimum wage or overtime pay. Recovering from a workplace injury without protections that your job will still be there when you can work again. Facing termination, jail, and even death for joining with co-workers to advocate for change.

Historically, workers and their unions forced major improvements in many of the most horrific conditions. They did it through collective bargaining, by coming together to elect worker-friendly representatives, and by pressuring those lawmakers for change. They left us with a legacy of a much improved workplace —but that legacy is under attack.

We need only look at the overhaul of labor laws in Michigan during the past few years to see how quickly anti-worker politicians can tear down our legal protections when they get into power. We have been hit with laws that forbid local

# CTU's uncontested election

n light of our current uncontested election, the leadership of CTU is considering a proposal to forego the expense and time-consuming effort of a general election under such circumstances in the future. Instead, we might consider affirming the placement of the candidates in uncontested "races" at a Membership Meeting. The change would require a constitutional amendment, which can only succeed with a 2/3 vote of the members. If the Executive Board decides to advance the proposal, Members will receive notice of it at least 20 days before the October 25 election.

jurisdictions from enacting better safety, wage, and benefit standards; an emergency manager law that allows the unilateral termination or alteration of union contracts; the infamous "right-to-work" laws; etc. Most of these laws interfere with our rights to freely bargain with our employer. And many more such laws have been introduced.

Rather than cowering or throwing up our hands in despair, workers and our unions are obligated to honor the sacrifices of those who went before

us and to ensure that the next generation of workers is not thrown back to those days where workers truly were "human capital." [Donna Maas]

How do we best protect ourselves? Besides having a strong contract, we get involved at the political level. As my friend and mentor, the late Professor Dan Kruger, always drummed into my head—unions must be engaged in all levels of the democratic process.

When we engage in politics, he said, we "serve as a countervailing force to the legislative agenda of businesses and other special interest groups."

And the most powerful reason that we must be engaged, he said, is that "POLITICAL ACTION BY UNIONS GIVES WORKERS A SEAT AT THE SOCIAL NEGOTIATING TABLE."

"Political action is part and parcel of a free democratic society," Kruger said, "and unions, as part of the democratic community not only do engage in political action, but are obligated to do so on behalf of their members and their interests."

In that spirit, we must elect the leaders who listen to us and represent our interests as workers. Our jobs, our total compensation, our contracts are all at stake. It couldn't be clearer at the state

level considering all of the laws that have been passed against us in the last few years. And for workers at Michigan's top three universities—Michigan State, Wayne State, and Michigan—we have a unique opportunity to elect the specific individuals who govern our workplaces. We want leaders who understand our contributions and sacrifices, leaders unwilling to address problems by shifting additional financial burdens onto working families. And we need to make sure the "Big 3" have each others' backs in this fight. Sure these are issues that impact us as university workers, but they also impact the economic health and future of the state and its communities.

So I'm asking for you to vote for those who have been identified as "labor friendly" in these races.

Please consider the following: For the State Board of Education—John Austin and Ismael Ahmed; for UM's Board of Regents—Laurence Deitch and Denise Illitch; for our MSU Board Trustees— Dianne Byrum and Diann Woodard; and for Wayne State's Board of Governors— Mark Gaffney and Yvette Anderson.

We are in the "education business" but we are also a major part of this state's economy. We are a valuable asset and we need to remember that as we vote.
