Who has my information?

ewer than 9,000 MSU individuals are taking advantage of the free All-Clear ID monitoring service offered by the university in the aftermath of a data breach announced in November 2016.

Although only 449 records were confirmed to be accessed, the thieves had the ability to access records of any of approximately 400,000 faculty, staff, and students employed by MSU between 1970 and November 13, 2016, and students who attended MSU between 1991 and 2016. The records in question included names, social security numbers, MSU identification numbers, and birth dates. **Not included** were passwords and financial, academic, contact, gift, or health information. As a result of the breach, the university hired AllClear ID to provide two years of identification protection and repair for over 400,000 current and former students and employees who were affected. ID continued on p. 3

There are two levels to this protection:

- 1. You must register for credit monitoring and protection. This is an important protection for which many individuals already pay, sometimes through their homeowners insurance. Here is an opportunity to receive the protection for free. Even if you already pay for similar insurance, a second layer of protection cannot hurt.
- 2. Identity repair assistance will be available to anyone as needed. No one needs to sign up for this service. However, repairing one's identity means that the damage is already done. Sign up for monitoring to receive real protection.



sonal crisis, or other calamity suddenly causes an issue on the job. The specific situation may be unexpected, but our union is ready. We provide the "plumber" when things go wrong.

Due to good planning, our union has withstood some awful economic forces and an increasingly hostile political climate. And it doesn't take a PhD to see that these hard times are not over. Michigan's legislature recessed at the end of 2016 with some really nasty anti-worker laws pending. In the new legislative session, we fully expect these laws to resurface. As always, we will keep you informed.

Our union is resilient because we have chosen to remain member-driven. As members, we provide the input, the direction, and the on-the-ground knowledge that allows the union to respond swiftly and effectively. We have invested in both education and two-way communication as well as staff development. If members continue to stay informed and involved, I am convinced our union will continue to be successful.

As you move into the swing of 2017, I encourage you to plan ahead. Make sure the union will be here if you have an emergency. Add union involvement to your New Year resolutions.
