# **Nominations Notice:**

ominations for the offices of President, Treasurer, four (4) Directors, and two (2) Audit Committee Members will be accepted September 3 through September 10, 2019.

The President, Treasurer, and three (3) Directors will be elected to serve terms of approximately two (2) years, specifically, from their date of installation through the installation date of their replacements elected in the union's regularly scheduled election to be conducted in October 2021.

One (1) Director will be elected for one (1) year to complete a vacated term, specifically from their date of installation through the installation date of their replacement elected in the union's regularly scheduled election to be conducted in October 2020.

One person will be elected to the Audit Committee to serve a term of approximately three (3) years, until the regularly scheduled election to be conducted in October 2022.

One person will be elected to the Audit Committee for two (2) years to complete a vacated term, specifically from their date of installation through the installation date of their replacement elected in the union's regularly scheduled election to be conducted in October 2021.

Written nominations will be accepted by the Elections Committee or their designees, including CTU Organizational Coordinator Tiffany Westendorf, at the CTU office from September 3 through September 10, 2019, by 5 p.m.

A nominations meeting will be held on September 10, 2019, at 5:30 p.m. at the CTU office, 2990 E. Lake Lansing Road, East Lansing, Michigan 48823. Nominations can also be made from the floor of the nominations meeting if the nominee is in attendance. The nomination period will close upon the conclusion of the nominations meeting at 6:30 p.m.

In order to make a nomination, a member must be in good standing. Nominees have to have completed their probationary period and be in good standing at the close of the nominations period. Self-nominations are permitted; seconds are not required. No member shall be allowed to accept the nomination for more than one position.

Every nominee will be required to indicate in writing, no later than the conclusion of the nomination period, whether she/he accepts or declines a specific nomination. The names of nominees who fail to accept their nominations will not appear on the ballot.

# Raises, dues, plans & holidays

ate summer greetings! It's August and we're already asking, "Where did the summer go?" Summer just never feels like it did when we were kids—when we got a *real* vacation.

Here at your CTU office, we are busy. We are preparing to hold this fall's elections and tackling some special projects. Of course, the day-to-day work of communications and defending members in the workplace is ongoing. And, while the MSU presidential search is complete, I am still involved in welcoming activities and meetings to help Dr. Stanley get acquainted with the university's staff and unions.

#### **April 2020 raise: 2.75%**

We continue our efforts to keep health care quality high and costs low so that our savings will pay off in higher raises—like the 2.75% general increase we will receive on April 1, 2020 (Good job, CTs!)

While we celebrate this success, however, I am aware that some university employees (including CTs) don't understand the MSU unions' groundbreaking efforts to control health care costs while pursuing raises. They are unaware of our historical 2006 initiative to ensure fully funded health care (with a no-premium option) by tying raises to health care savings. They don't know about the long hours we put into partnering with the university, on an ongoing basis, to research and review health care vendors and plans. They don't know that all of the unions at MSU work in coalition to achieve quality health care and keep costs low-a win for our members, for the university, for taxpayers.

So, one of our projects in the coming months is talk about our achievements, how health care works at MSU, and our constant efforts to improve the system. [Eric Tervol]

#### Why should I pay union dues?

Most of us know that Michigan rightto-work laws allow employees to receive all union negotiated benefits, pay raises, and representation but pay zero to support those efforts. We are subsidizing our coworkers who make this decision.

I am happy to report that the majority of CTs understand the need to support their union resource. They want to pay their fair share. If someone is confused or not sure about membership, I appreciate "the ask." When it's explained, CTs almost always "get it" and check the "yes" box.

I find that gratifying, but it also shows the need to educate everyone in the bargaining unit, especially new hires, about the value of being in a union.

#### Learn about your union

Another way to learn about your union is by attending New Member Orientations. They are instrumental in allowing new and long-term members and union leaders to meet and ask questions about dues and lots of other issues. Watch for announcements about upcoming meetings.

New member meetings almost always include conversations about the value of unionized labor, which I view as being in a partnership with the employer. Unions help lay a foundation of mutual respect in the workplace that leads to the success of both workers and the employer. Again, I am finding that we need more education on what labor has done for society and the workplace. If you have ideas on how we share this or provide for more educational opportunities, please let me know.

And please try to join us this fall for a new member orientation. Perhaps you'll learn something new.

# 2.75%

For the second year in a row, we kept increases in health care costs low enough to ensure the maximum general raise of 2.75%. CTs will receive this increase next year on April 1, 2020. Congratulations to the members of all of MSU organized labor for our excellent stewardship of our health care benefit.

# Leadership duties

he terms of our president, treasurer, four directors and two Audit Committee members are scheduled to end this October.

To help us decide who to support, or whether or not to run, it's important to know the duties of the positions.

The duties of officers on the Executive Board are laid out in Article V of our Constitution (www.ctumsu.org/about-the-ctu/constitution-of-the-ctu or call the office at 355-1903 if you don't have internet access).

In order to fulfill those duties, elected officials are expected to take on many responsibilities. Those expectations are detailed on this page.

The 2019 CTU Elections will be held Tuesday, October 22.

#### **President**

The President of the CTU is expected to fulfill all of the responsibilities listed for directors and officers. In order to fulfill the Constitutionally mandated responsibilities of the Office, the President also is expected to:

- keep the Executive Board and organization on track between meetings;
- structure Board meetings;
- provide a long-range view of the organization;
- act as official spokesperson for the CTU, internally and externally;
- •remind people of deadlines;
- balance a 40-hour week through the use of flex and comp time, and report to the Board if work demands overload status;
- report activities to the Board and members;
- use full-time released time from MSU position;
- •chair Executive Board meetings and

#### **Directors and officers**

In order to fulfill the Constitutionally mandated responsibilities of any position on the CTU Executive Board, those elected are expected to:

- carry out and honor the oath of office;
- commit the time required to serve the Union including some day, evening, or weekend hours;
- •support unionism;
- uphold the Union mission and direction as set by the Executive Board and the CTU Constitution;
- make decisions and create policy;
- •use input/data from membership, experts, and staff when time permits;

- serve on either the Grievance, Appeals and Trials or Finance Committee;
- •represent the CTU at all times;
- attend some labor functions as a CTU representative;
- attend Board meetings, UR meetings, regular and special membership meetings (attendance mandatory);
- •when possible, work in conjunction with URs on membership issues;
- •keep URs informed and in the loop;
- •be able to work as part of a group of people;
- •honor issues of confidentiality;
- •control rumors/misperceptions.

#### **Treasurer**

The Treasurer of the CTU is expected to fulfill all of the responsibilities listed for directors and officers. In order to fulfill the Constitutionally mandated responsibilities of the Office, the Treasurer also is expected to:

• oversee fiduciary responsibilities, pay bills, cooperate with the auditor, research community solicitations,

report on the financial impact of decisions;

- •chair the Finance Committee;
- prepare the budget with the Finance Committee;
- make quarterly reports to the membership;
- •use 25% released time from MSU position in order to fulfill duties.

#### **Audit Committee**

This description of the Audit Committee and the duties of its members is taken from Article VI of the Constitution:

- The Audit Committee shall consist of three members. They shall be elected for staggered three-year terms with said election held at the same time and under the same rules as apply to the Executive Board. Members of the Audit Committee may not be members of the Executive Board.
- The Audit Committee shall make

- or cause to be made at least a yearly audit of the Union's finances and shall report to the membership the result of such audit.
- The Audit Committee shall monitor normal operating expenses and shall serve as an independent communications channel between the members of the Union and the custodians of the Contingency Fund for verification of withdrawals from that fund.

negotiations, and sit as *ex officio* member on all internal committees;

- supervise staff;
- •chair the Personnel Committee and

report personnel issues to the Board for decision-making;

•vote only to break a tie in an Executive Board vote.

That night, nominations will be accepted from the floor during a nominations meeting at the CTU office from 5:30 to 6:30 p.m. The nominations period will close upon the conclusion of the meeting. Candidates will be given an opportunity to speak at this meeting. Upon submission of their nominations, candidates will be given a list of rules and guidelines for the election process.

**September 17.** Deadline of 5 p.m. for candidates to submit a campaign statement (up to 500 words, electronic format preferred) to Westendorf for publication in *CT News*. Photo arrangements must be made at this time: Contact Cheryllee Finney at 432-9580 or *Cheryl@ctumsu.org*.

October 1-16. Requests for absentee ballots accepted. Requests must be received by 5 p.m. on October 16.

**October 14.** Week of publication for the special elections edition of *CT News*.

October 14–18. The membership list will be available for inspection by the candidates between 8 a.m. and 5 p.m., Monday through Friday. Arrangements must be made by contacting a member of the Elections Committee or Westendorf.

October 14. Candidate forums begin.

October 16, 17, 18, 21. Walk-in, absentee voting available at CTU (specific times not yet set). On-site voting days for Detroit Medical Center, Flint, Grand Rapids, and Macomb sites will be announced.

October 22. Polling 7:30 a.m. to 5:30 p.m. Absentee ballots must be received at the CTU office by 5 p.m. Official vote count begins at 6 p.m.

**October 23.** Officers installed at the Membership Meeting.

**October 29.** Deadline for receipt of election protests.

**November 12.** Runoff election if required.
